Winter Meeting - Crowd Sourced Audit

The ICO Winter Meeting took place at the Albert Theatre in the RCSI on the morning of the 16th November. The aim of the forum was to explore the possibility of a national audit co-ordinated by the College and open to all members of the ICO.

Mr Donal O'Connor, Adjunct Lecturer in Surgery at Trinity College Dublin, gave a presentation advising on how best to structure the template for a 'crowd sourced audit'. He outlined the clinical value of multi source data collection by medical students (STARSurge), trainees (EuroSurge) and GlobalSurge Collaborative. Large numbers of patients are studied in a short time, while preventing repetition and poor utilization of finite resources it allows greater generalisability across a multi-centre setting. Supervision and electronic security are essential.

A proposed National Audit on LogMAR Visual Acuity recording was outlined by Mr John Doris. There is marked variability in how vision is recorded, the methods used and the issues surrounding comparative analysis.

Since the national policy to introduce

LogMAR VA Screening of School Children was introduced in 2015 and the Diabetic Retinal Screening Programme is planning to adopt LogMAR vision notation, it was proposed that the members look at their current VA systems & assess any need for change.

Participation in the national audit is voluntary and hope is that the information will give the members data to support any application for capital expenditure required in a business plan to the HSE.

A sample template will be emailed to members shortly.

The RAMI Ophthalmic Section meeting followed and the College congratulate Emma Duignan, Olga Klis, Christine Goodchild, Niamh Wynne, Maxwell Treacy and Emily Hughes who were presented with the European Board of Ophthalmology Diploma.

The session on the morning of Friday 8th on "Life and Sight Threatening Conditions in Ophthalmology" will welcome keynote speakers from Ireland and the UK, each focusing on a sub specialty of ophthalmology and the discussion of case examples that emphasise the importance of the first visit to the outcome.

Mr Mike Burdon, President of the Royal College of Ophthalmologists, London, will present on neuro-ophthalmology, Mr Alan Mulvihill, Edinburgh, on paediatric ophthalmology, Dr Evelyn O'Neill, Dublin, on emergency medicine and Miss Julie Sylvestrie, Belfast, will discuss retina cases.

Winner of ICO/Novartis Eye Research Bursary 2018 Announced at Adare Retinal Meeting

The winner of the annual ICO/Novartis Research Bursary for 2018-19, Emily Greenan, was announced at the Annual Adare Retinal Meeting in Limerick on September 28.

The research focusing on ocular inflammation in dry eye disease will be carried out between the Royal Victoria Eye and Ear Hospital, Dublin and the Royal College of Surgeons in Ireland as part of Dr Greenan's PhD under the supervision of Conor Murphy and Dr

Joan Ní Gabhann at the Department of Ophthalmology and Molecular and Cellular Therapeutics, RCSI.

Explaining the rationale of the study and the significance of the being awarded funding for his project, Emily said, "I am both delighted and honoured to be this year's recipient of the ICO/ Novartis Research Bursary grant. Our research is aimed at inflammation of the ocular surface, seen to be the key driving factor underlying the pathogenesis of dry eye disease. By identifying the dysregulated panel of microRNA, short sequences of mRNA that normally control the production or inhibition of inflammatory proteins, we hope to offer new therapeutic targets for the disease. We will combine this knowledge with recently developed nanoparticle drug delivery systems to provide a more effective and targeted treatment option for patient use in the future."

Emily will present an update on her study at the ICO Annual Conference next May.

Professor Peter Barry Memorial Lecture



The second annual Professor Peter Barry Memorial Lecture was given by Mr Paul Rosen, John Radcliffe Hospital, Oxford on Thursday 15th November last. Mr Rosen spoke on 'Cataract Surgeon Meets Retinal Surgeon: Front to Back or Back to Front?' to a full auditorium at the Conference and Research Centre, Eye and Ear Hospital.

Like the late Peter Barry, Paul is a former President of the European Society for Cataract and Refractive Surgery (ESCRS) and both an accomplished and internationally renowned cataract and vitreoretinal surgeon. Furthering this theme, he maintained that the ideal intervention for severe ocular trauma, involving both

anterior and posterior segments, was a dual trained cataract and vitreoretinal surgeon. He pointed out that 9 of the 13 previous Presidents of ESCRS were also vitreoretinal surgeons.

Paul discussed the optimum timing of secondary intervention, types of secondary lens implants and various techniques of fixation, suturing,

glueing or even cautery placement. Interactive discussion followed on long term stability, effects on the cornea, biometry accuracy and practical useful suggestions. Mr Rosen was then presented with the Lecture Medal by Mrs Carmel Barry. This event was kindly supported by Thea Pharmaceuticals.

Bayer/ICO Clinical Fellowship

Report by Elizabeth McElnea, Joint Winner of the Bayer/ICO Clinical Fellowship in Ophthalmology 2016/2017

The inaugural Bayer/ICO Clinical Fellowship in Ophthalmology 2016/2017 was awarded to trainees Andrea Ryan and Elizabeth McElnea at the ICO Winter Meeting in December 2016.

Andrea Ryan has since successfully completed her Fellowship in Medical Retina at Moorefields Eye Hospital in London.

Elizabeth McElnea has completed training at Macclesfield District General Hospital and Aintree University Hospital in the United Kingdom. She subsequently travelled to the Royal Victorian Eye and Ear Hospital in Melbourne where she is completing further surgical training in the Orbit, Oculoplastics and Lacrimal unit there.

In her time in Australia to date Elizabeth has already been delighted with the cases relevant to her chosen subspecialty to which she has been exposed – in terms not only of volume but also variety, complexity and rarity.

She describes an excellent timetable with provision for both supervised and unsupervised surgery, pre-operative and post-operative clinics that enable monitoring of each patient's complete clinical course, completion of a number

of clinical research projects and even some evenings by the beach!

Elizabeth has been impressed by the reception she has received in Melbourne since her arrival, describing how the staff at the unit and indeed the hospital as a whole extends a very warm welcome each year to a large number of trainees from a wide range of countries. She notes that a highlight of the fellowship is undoubtedly the opportunity to work with so many people from such a variety of training backgrounds.

Elizabeth said the hospital's approach to education and training is also enviable, with an ambitious weekly program delivered by a number of enthusiastic trainers and a constant interest in the completion and publication of high quality clinically based research.

Her travel to further afield has however only served to increase Dr. McElnea's admiration for many of the ophthalmology departments she has worked in to date which, she believes, provide fantastic patient care often with greater limitations on resources.

Elizabeth hopes soon to be competent in the assessment, diagnosis, treatment and follow-up of patients

with the full complement of conditions encountered in her subspecialty. She very much looks forward to bringing the skills and expertise gained during these latter portions of her training back to the Irish health service and the large and indeed growing population of Irish patients affected.

Asked of the impact of receiving the Bayer/ICO Fellowship award Elizabeth said that this has indeed been massive.

"The award is important in that it acknowledges the challenges posed by fellowship training. In doing so it also highlights the efforts made by many of my predecessors to obtain the same without similar funding opportunities. I have received excellent training under the supervision of a number of fantastic mentors in a variety of settings when in the absence of the fellowship award any one of these may have been impossible. I am extremely grateful for the support offered by Bayer and the ICO and hope that in future more trainees benefit similarly."

CME - Personal Development Plans

Mr Patrick Condon UKISCRS Lifetime Achievement Award

The ICO warmly congratulate our esteemed colleague, Patrick Condon, on his recent accolade of a Lifetime Achievement Award by the UKISCRS in recognition of his outstanding work and contribution to the specialty. Patrick presented his Lecture 'How Shakers and Movers, I Had the Privilege to Know, Shaped my 50 Years in Ophthalmology' at the UKISCRS 42nd Annual Meeting which took place in Leicestershire from 7th – 9th November 2018

A snapshot about Patrick Condon:

Patrick Condon did a 6 year residency program in ophthalmology at the Royal Eye Hospital, London which involved a rotation to the Croydon Eye Unit and Lambeth – St Thomas's Hospital group. He subsequently became a consultant at the Bromley and Farnborough Hospital group for two years before returning to Waterford, Ireland.

During his Waterford appointment, he introduced IOL implantation in the 70s, followed by phacoemulsification surgery which he initiated in Ireland in 1987 reporting on his first 150 cases a year

later. In conjunction with Prof. Michael O'Keeffe at the Mater Hospital in Dublin, he was the first to introduce LASIK to Ireland in 1993 with the use of the Automated Lamellar Keratoplasty micro-keratome.

During the late 90s he became actively involved with UKISCRS, becoming president in 1994 and delivering the Choyce Medal Lecture in 2004. Following his appointment in 1982 by Dr Cornelius Binkhorst as the Irish member of the European Intraocular Implant Council, forerunner of the ESCRS, he became congress chairman and treasurer of the ESCRS for almost 10 years, for which he was awarded the Grand Medal of Merit in 1999, followed by the Ridley Medal Lecture in 2005.

Being a member and a constant contributor to each yearly meeting of ASCRS and involved in the amalgamation of the European and American Journals to form the JCRS, he was presented with the ASCRS Hon. Guest Award in 2009 at the annual meeting in San Francisco.

In his lifetime achievement lecture, Patrick reflected on the past 50 years, including photographs and video sequences collected from his wide world travels and experiences.

Minister for Health officially opens UL Hospitals Group Cataract Centre at Nenagh Hospital

On November 5th, Minister for Health Simon Harris, officially opened the UL Hospitals Cataract Centre at Nenagh Hospital.

Under a nationally funded initiative, Nenagh has become a national centre of excellence for cataract surgery. All suitable cataract surgery within UL Hospitals Group is to migrate from University Hospital Limerick (UHL) to the new theatres at Nenagh.

The first procedure under the initiative was completed in July of this year and with one list of 10-12 patients a day being completed once a week, it is expected that 200 patients will be taken off the surgical waiting list by the end of 2018.

The goal is for the theatre in Nenagh to move from one-day-a-week to five days a week in 2019, when it is expected at least 10 times that number of procedures will be carried out in a full year. This will see Nenagh Hospital not only play a significant role in reducing waiting lists for cataract surgery in the Midwest but will also make a mark nationally by insourcing patients from other regions.

Staff at Nenagh Hospital and the Perioperative Directorate at UL Hospitals Group have worked closely with the HSE Acute Hospitals Division, the Department of Health and the National Treatment Purchase Fund (NTPF) in securing the additional resources and funding for this initiative.

In June 2018, the Directorate completed a position paper to establish a stand-alone, high-volume, consultant-led cataract theatre at Nenagh Hospital. This resulted in a commitment of €1 million in capital funding for equipment and additional funding for the extra medical, nursing and administrative resources required to run the service.

Speaking at the official opening, Minister Harris said Nenagh will be a centre of excellence for the UL Hospitals Group and surrounding

counties. Minister Harris said, "Improving access to treatment for patients is a key priority of Government. The opening of the UL Hospitals Cataract Centre at Nenagh Hospital will deliver on this objective, providing improvements for patients in the Midwest and surrounding areas."

Prof Colette Cowan, CEO, UL Hospitals Group said staff were conscious that there was great potential in Nenagh, in line with the national clinical programme for Ophthalmology Model of Eye Care, to make a real difference in cutting waiting lists for cataract surgery initially in the Midwest and ultimately around the country. She added, "The demand for cataract surgery will only increase as the population grows and ages. This national centre helps secure the future of Nenagh Hospital and means more timely, more accessible
